

Pursuant to the decision of the High Power Committee in its meeting held on dtd. 17.8.19 and as per the guidelines issued by the Government in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd. 23.9.96 read with G.O No. 29519/SME dtd. 26.9.1998, <sup>Conditional</sup> No Objection Certificate (NOC) is hereby granted in favour of GSEM School-II, Sarakana, Ballianta, Khordha to open Self Financed High School upto class-X which is to be affiliated to CBSE subject to following terms and conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O No. 30720/SME dtd. 23.9.96 and No. 29519/SME dtd. 26.9.1998 read with G.O No. 10011/SME dtd. 11.6.2004.
2. The school shall be open to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or Grant-in-Aid (either recurring & non-recurring) will be claimed by the institution from the Government at any point of time to meet any kind of expenditure towards salary cost or any non-salary requirement.
4. The High Power Committee shall be competent to review the NOC granted to the Institution concerned and shall be competent to withdraw the same if any of the terms and conditions mentioned in this NOC is violated.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Orissa Education Act-1969.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
